- All invoices except for sales agreements are due and payable within 30 days from date of invoice, sales agreements are due within 10 days from invoice date.
- If equipment is rented for more than 4 weeks, periodic unsigned invoices will be issued for rental charges due. All such invoices are due and payable within 30 days of the invoice date.
- At the discretion of Equipment Rental Source, LLC, any account with a delinquent balance may be placed on a cash basis at any time, and the equipment picked up without notice.
- Equipment Rental Source, LLC files preliminary lien notices and mechanics liens at its discretion. This is a company policy and is not a reflection of credit standing.
- For each delinquent account, customer agrees to pay a monthly service charge equal to 1.75% of the past due balance or the maximum service charge permitted by law to the applicable state.
- Customer agrees to pay all reasonable attorney fees, collection costs, and court costs incurred by Equipment Rental Source, LLC in enforcing these terms and conditions.
- Customer authorizes Equipment Rental Source, LLC to obtain credit reports, trade reports, and bank references for the purpose of determining the extension or continuation of credit to customer.
- Customer will provide Equipment Rental Source, LLC with a copy of an insurance certificate that names Equipment Rental Source, LLC as the loss payee and additional insured in an amount to cover replacement cost for rented equipment, and further agrees to reimburse Equipment Rental Source, LLC for lost rental revenues during periods of repair or replacement of damaged or stolen equipment.
- Customer agrees to the terms and conditions as stated on each and every Equipment Rental Source, LLC agreement, contract, or invoice.
